Eleni Koutsouraki is Assistant Professor of *Refugee Protection, Law and Rights in the Euro-Mediterranean area* at the Department of Social Work of Hellenic Mediterranean University. She holds a law degree from National Kapodistrian University of Athens and a master's degree in Human Rights and Humanitarian Law from University Paris II Panthéon Assas, where she also completed her PhD thesis on the rights of asylum seekers in the EU and their situation in comparative law (France, Greece) in 2014. She has also completed post-doctoral research related to EU asylum law at Panteion University with scholarship granted by Greek State Scholarships Foundation. She has attended specialization courses in refugee protection at René Cassin International Institute for Human Rights, Université Libre de Bruxelles and San Remo International Institute for Humanitarian Law. She speaks French (DALF, C2), English (Proficiency of Cambridge, C2), German (Zertifikat Deutsch, B1) and Spanish (Initial, B1). At Hellenic Mediterranean University she teaches Law, Civil and Social Rights, Refugee Protection, Protection and defence of human rights, Good practices of crisis and emergency situations management. She has also taught courses of refugee law, minority protection, human rights and international law at undergraduate and postgraduate level at Panteion University, Democritus University of Thrace and Hellenic Open University. She is attorney at law member of Nafplion Bar Association and has represented refugees before Greek authorities, courts and the European Court of Human Rights.
